MEMBERSHIP APPLICATION PROCEDURE

This is the procedure when applying for membership in the MANG Aero Club. This process begins when you decide to apply for membership and requires two to three weeks to complete.

1. Send the following documents to the Membership Director:
 - a. Membership Application and Application Fee in the amount of \$25, **non-refundable**. Make check payable to "MANG Aero Club".
 - b. Photocopy of:
 1. Your driver's license, both sides
 2. Any recent envelope addressed to you with a cancelled stamp
(NOT A SELF ADDRESSED STAMPED ENVELOPE)
 3. Your pilot license or student medical certificate, both sides
 4. Your medical certificate, both sides
 5. If flying using Basic Med, the completed checklist signed by a licensed physician, and the self-assessment quiz results.
 6. Your most recent flight review sign off
 7. A copy of the last page of your logbook
 8. A copy of the last page of your logbook that indicates total accumulated hours
 9. A reference name and phone number for the last FBO/Club/School that you used an aircraft from, and approximate date of last use.

The Membership Director will copy and forward the appropriate documents to the President, Secretary, Treasurer, and Safety Officer. Allow one week for distribution and review of your documents.

2. The board will review your application, documents, and any comments from an initial interview, and will vote to accept or reject the applicant for immediate membership or to be added to the waiting list (when the club is at full membership of 55 members). Allow one week for a decision.
 - a. If accepted, your check will be cashed, and the application is **non-refundable** from this point forward. You will be advised of your position on the waiting list if applicable. Approved applicants put on the waiting list will be called in the order their application package (application, documents, and application fee) were received.
 - b. If you are not approved for membership, your check will be refunded (**except \$25 Application Fee**).
 - c. **If you elect to withdraw from the waiting list, your application fee is not refundable.**
 - d. If you elect to defer membership when offered, your application will become the last on the waiting list.

3. When the review process has been completed, you will be notified by the Membership Director of the Club's final decision. For those approved for membership, an interview date and time will be set up for the New Member Induction Process. Other board members will be invited (usually 1 or 2). This is a requirement of the club bylaws. Allow one week for proper board member notification.

4. At the New Member Induction, you will be issued a set of keys to the aircraft, advised the passcode for hangar entry, an application to procure a security badge at the Detroit Metro Airport security office (required for access to Bird Cage hangar area), and given User ID and Password to access the club's online reservation system and other web site member documents. Information from the bylaws and regulations that are critical to club membership will be reviewed.
